Comptrollers Report:

In the off season, we purchased a Quick Books program that is our new platform for billing. Consistent with years past, invoices go out the first/second week of March and the first/second week of September with payment due by April 15th and October 15th. Late payment fee and interest charges will be assessed when applicable. It is your responsibility to notify us of any changes in your contact information or if you do not receive a bill.

We thank Nicole for her diligence and ensuring that our lot is properly utilized. Please provide your cooperation in following the protocols in place.

Nicole Zambell (22 West) will be distributing parking passes this weekend to members who are in good standing. If you are past due with the Association or TRMUA, you are not eligible to receive the passes. The parking pass must be displayed in your car. If you fail to place the pass in your vehicle, you will receive a warning which may lead to penalties and the towing of your vehicle.

Thus far, 30 parking passes have been sold. As previously approved, we are limiting nonmember seasonal rental parking spots to 40.

Beach Matters: Beach badges have recently been ordered and are not available at this time. We have been advised that delivery is expected mid-June and will be distributed to members who are in good standing once received. In addition to being current with the Association and TRMUA, you will have to be current with TR Township.

As of this writing, the Beaches have opened for the season, however, we must conform to our Association, Local and State social distancing protocols. The situation is very fluid and subject to change at any time. Our website has a link to the most recent Executive Order signed by Governor Murphy, Toms River Township guidelines and a Beach Patrol 2020 Flyer prepared by our beach captain, Joe Soporowski. Please take the time to familiarize yourself with these important documents.

Lifeguards and badge checkers are expected to start the season effective June 20th. Over the next few weeks, we will be reviewing and educating ourselves with best practices and all of the requirements that our Association must follow. We will provide updates and official communication over the next few weeks.

Due to compliance requirements of the US Lifeguard Association and the State of NJ, we have been advised that additional costs associated with the purchase of various equipment are anticipated.
